Declaration of eligibility for membership of Harrow High School's Governing Body

- 1. I am aged 18 years or over at the time of my election or appointment.
- 2. I am not a registered pupil at this school.
- 3. I have not been subject to a bankruptcy restriction order or an interim order.
- 4. I have not had my estate sequestrated and the sequestration order has not been discharged or annulled.
- 5. I have not been disqualified from serving as a company director under the Company Directors Disqualification Act 1986, nor am I subject to an order made under section 429(2) (b) of the Insolvency Act 1986 for failing to make payments under a county court order. I have not been disqualified from Part 2 of the Companies (Northern Ireland) Order 1989.
- 6. I have not been removed from the office of charity trustee or trustee for a charity by an order made by the Charity Commissions or the High Court on grounds of any misconduct or mismanagement, or under section 7 of the Law Reform (Miscellaneous Provisions) (Scotland) Act 1990 from being concerned in the management or control of any body.
- 7. I am not included in the list of people considered by the Secretary of State as unsuitable to work with children.
- 8. I have not been disqualified from working with children or subject to the direction under Section 142 of the Education Act 2002.
- 9. I am not disqualified from registration for childminding, or providing day care.
- 10. I am not disqualified from registration under Part 3 of the Childcare Act 2006.
- 11. I have not been subject to civil litigation that has or is likely to lead to negative press coverage that could bring the reputation of the school into disrepute.

- 18. Any other change affecting my eligibility to be a governor listed above.
